**Footnotes**

ORDER OF AUSTRALIA (IRE) broke slowly from the gate, was rushed up into contention into the first turn, stalked the pace along the backstretch, was in

the four path into the lane, made a bid in the stretch, edged clear while three wide and held off closing rival in the final stages. CIRCUS MAXIMUS (IRE) chased the pace early on, was off the rail into the lane, gradually altered out down the lane under a late rally, finished willingly but too late. LOPE Y FERNANDEZ (IRE) raced back early on, was in the four path into the lane, rallied down the lane and finished willingly in the late stages. IVAR (BRZ) chased the pace early, was on the inside into the lane, altered out down the lane with a mild gain in the late stages. UNI (GB) was bumped at the start and raced back early on, swung out into the seven path entering the lane, rallied in the stretch while widest and finished willingly in the final stages. HALLADAY set a clear pace from the outset, was off the rail into the lane, clung to the lead near the eighth pole, gave in nearing the sixteenth pole and yielded in the final stages. KAMEKO stalked the pace early, was on the inside into the lane, made a bid in the stretch from the rail but flattened out late in the drive. FACTOR THIS bobbed at the start, tracked pace early on, was in the three path into the lane while making a bid, was slightly bothered down the lane and weakened late in the drive. SISKIN was unhurried early on, raced along the inside into the lane with a minor gain in the stretch run. RAGING BULL (FR) raced back early on, was in the four path into the lane with some late gain in the stretch drive. DIGITAL AGE (IRE) lunged at the start and trailed the field early on, swung out into the seven path entering the lane and leveled off late in the stretch. CASA CREED was through after a half. MARCH TO THE ARCH raced five wide along the backstretch, was in the five path into the lane and no factor down the lane. SAFE VOYAGE (IRE) rider lost action multiple times, never made a bid.
